



## COOKIES POLICY

### I. Introduction

We are glad that you have visited our website. We have prepared this cookies policy for you, as we want you to feel comfortable while you are surfing our website. The policy will help you learn for instance:

- a) The definition of the cookies.
- b) What cookies we use and why.
- c) How the cookies affect your privacy.
- d) What rights you have under the GDPR<sup>1</sup> and telecommunications law<sup>2</sup>.

### II. The definition of the cookies.

1. In the simplest terms, the cookies are small text files stored on your computer or smartphone when you view our website. There are different types of cookies. We have divided them for you into two groups:
  - a) Essential ones, for using our website.
  - b) Other.
2. The cookies which are essential for using our website are used, for instance, to ensure the stability of the website (they measure traffic, protecting us against traffic congestion), to remember your selected privacy preferences, to fill in online forms provided by us, to save the contents of your shopping cart and to monitor your login status. We use these cookies by default, that is to say we store them on your computer or smartphone when you access our website (pursuant to Section 173 (3) of the Telecommunications Act).

3. We only use other cookies if you have given us your consent to do so. You will read more about them in the next section of our Policy.

### III. What cookies we use and why.

<p><b>Essential cookies</b> – they ensure the proper functioning of our website and its basic functions. Without them, you will not be able to use our online services properly. These cookies are exempt from the requirement to obtain your consent (Section 173 (3) of the Telecommunications Act).</p>

cookieyes-consent	CookieYes sets this cookie to remember your consent preferences so that your preferences are respected during subsequent visits on this website. It does not collect or store any personal data of website visitors.	1 year

<p><b>Functional cookies</b> – functional cookies help perform certain functions, such as sharing website content on social media platforms, collecting feedback and other third-party functions.</p>

pll_language	PolyLang sets this cookie to remember your chosen language when you revisit the website and to obtain language information when it is not available from another source.	1 year
yt-remote-device-id	YouTube sets this cookie with embedded YouTube videos to store the user's video preferences.	Never
ytidb::LAST_RESULT_ENTRY_KEY	The ytidb::LAST_RESULT_ENTRY_KEY cookie is used by YouTube to store the last search result entry that was clicked on by a user. This information is used to improve the user experience and ensure more relevant search results in the future.	Never
yt-player-headers-readable	The yt-player-headers-readable cookie is used by YouTube to store the user preferences related to video playback and interface, improving the user's viewing experience.	Never
yt-remote-connected-devices	YouTube sets this cookie with embedded YouTube videos to store the user's video preferences.	Never
yt-remote-session-app	The yt-remote-session-app cookie is used by YouTube to store user preferences and interface information for the embedded YouTube video player.	Session

yt-remote-cast-installed	The installed yt-remote-cast cookie is used to store the user's video player preferences with an embedded YouTube video.	Session
yt-remote-session-name	The yt-remote-session-name cookie is used by YouTube to store the user's video player preferences with an embedded YouTube video.	Session
yt-remote-cast-available	The yt-remote-cast-available cookie is used to store the user's preferences as to whether or not the upload function is available on their YouTube video player.	Session
yt-remote-fast-check-period	The yt-remote-fast-check-period cookie is used by YouTube to store the user's video player preferences for embedded YouTube videos.	Session

**Analytical cookies** – analytical cookies are used to understand how users interact with the website. These cookies help to provide information on metrics of the number of visitors, rejection rates, source of traffic, etc.

_ga_*	Google Analytics sets this cookie to store and count page views.	1 year 1 month 4 days
_ga	Google Analytics sets this cookie to collect visitor, session and campaign data and track how uses use the website for the analytics report. The cookie stores information in an anonymised way and assigns users a randomly generated number to identify visitors.	1 year 1 month 4 days
_gid	Google Analytics sets this cookie to store information about how visitors use the website and to create an analytics report on website performance. Some of the data collected is related to the number of visitors, their origins and the pages they visit anonymously.	1 day
_gat_gtag_UA_*	Google Analytics sets this cookie to store a unique user identifier.	1 minute

**Advertising cookies** – advertising cookies are used to deliver personalised advertising to users based on the pages they have previously visited and to analyse the effectiveness of the advertising campaign.

YSC	YouTube sets this cookie to track views of embedded videos on YouTube pages.	Session
VISITOR_INFO1_LIVE	YouTube sets this cookie to measure bandwidth, determining whether the user is using the new or old player interface.	6 months

VISITOR_PRIVACY_METADATA	YouTube sets this cookie to store the user's cookie consent status for the current domain.	6 months
PREF	The PREF cookie is set by YouTube to store such user preferences as language, search results format and other customisations of YouTube videos embedded on various websites.	8 months

#### **IV. Consent to the installation of cookies**

1. During your visit to our website, a banner will be displayed to inform you that it uses cookies. If you select the "Accept all" option, this will mean that you accept all the cookies placed on our website and confirm that you have read the information on the cookies and the purposes for which they are used, as well as when data collected with the help of cookies is transferred to our partners.
2. Do note that your consent is not required for the essential cookies, as such cookies ensure the full and uninterrupted functioning of our website. These cookies are exempt from the requirement to obtain your consent (pursuant to Section 173 (3) of the Telecommunications Act).

#### **V. No consent to the installation of the cookies**

If you do not want our cookies to be stored on your device, you can select the "Reject" option. By selecting this option you will reject all but the technically necessary cookies that we use on our website.

#### **VI. Modifying the cookies settings**

You can manage your cookie preferences in detail by selecting the "Customise" box on the cookie banner displayed to you.

#### **VII. Personal data**

As some of the cookies we use constitute personal data, we want you to be aware of your rights under the GDPR:
